It was agreed to organise this event on October 13 and 14.

The dates have to be coordinated with UEFA, the contracts will be signed afterwards.

Outlook to future AEFCA-Events :

February 6, Brussels :

AEFCA-President Walter Gagg will sign a Memorandum of Understanding to Italian Foundation « Insieme contro il cancro (Together against cancer) », that is patronaged by the President of the European Parliament Dr. Antonio Tajani.

Three years ago the Foundation started a project « The Coach as a health Ally », that should be spread on European level, supported by AEFCA.

February 7, Brussels :

AEFCA-President Walter Gagg and SG Jürgen Pforr will negotiate with the organisers of the 2<sup>nd</sup> AEFCA-Legal-Symposium, that will take place in Lisboa April 25 and 26, 2019.

AEFCA-2<sup>nd</sup> Vice-President Jose Pereira, Vice-President Luca Perdomi and Sergio Araujo will inform about the conceptual planning of the event.

February/March :

Sergio Araujo, Legal Department, will prepare a meeting to FIFPRO-Representatives in Amsterdam to start our cooperation by signing a Memorandum of Understanding.

April :

The 2<sup>nd</sup> AEFCA-Legal-Symposium will be organised in Lisboa/Portugal starting April 25 at 0900 and ending April 26 at 1200.

Arrival day in Lisboa will be April 24, departure day will be April 26.

Next AEFCA-ExCo-Meeting is scheduled one day before the 2<sup>nd</sup> AEFCA-Legal-Symposium in Lisboa. (ExCo-Meeting on April 24 starting about 1400)

October :

The 40th AEFCA-Symposium will be hosted by Polish Coaches-Association STPN in Warsaw. Arrival day and ExCo-Meeting is planned for October 12, October 13 start of Symposium, October 14 end of Symposium, October 15 departure day.
